

The ASE Indices Quarterly review

June 30, 2025

The Amman Stock Exchange (ASE) has conducted the periodic quarterly review of the ASE indices constituents in purpose of ensuring that these indices reflect the market performance and the trading activity of the listed companies. By this rebalancing, the activity of listed companies in regard to trading during the last quarter has been reviewed. After that, the ASE has conducted its screening process for all listed companies based on the criteria used by the ASE represented by full market capitalization of the companies and the number of trading days during the last quarter.

As a result of this review, 6 companies have been excluded from the general index sample ASEGI, and another 3 companies have been added. The companies that have been excluded from the index sample were: Invest Bank, Aldaman for Investments, Petra Education Company, Offtec Holding Group, Al-Faris National Company for Investment & Export, and Jordan Vegetable Oil Industries.

The companies that have been added to the index sample were: Jordanian Expatriates Investment Holding, Al Sanabel International for Islamic Investments (Holding), and Comprehensive Multiple Transportations.

As part of the process, the ASE calculated the free float for all listed companies on the ASE based on the data received from the Securities Depository Center. Note that the ASE is setting a 10% cap for the company's weight in the index to prevent the index from being dominated by individual companies.

Regarding the general index ASEGI, the full market capitalization of the index constituents represents 92.8% of the total market capitalization of the companies listed on the ASE. The free float market capitalization of the index constitutes represents 94.5% of the total free float market capitalization of the listed companies on the ASE.

As for the ASE20 index and ASETR index sample, one company has been excluded from the index sample, which is Invest Bank, and another one company has been added to the sample, which is Arab Jordan Investment Bank. The full market capitalization of the index constituents represents 85.8% of the total market capitalization of the companies listed on the ASE, while the free float market capitalization of these companies represents 87.0% of the total free float market capitalization of the ASE listed companies.
