

## **The Thirteenth Meeting of the General Assembly of Amman Stock Exchange**

March 18, 2012

The 13<sup>th</sup> General Assembly of ASE was held on Thursday 15/3/2012. The meeting was chaired by the Vice Chairman of the Board Dr. Bashir Zu'bi, and attended by Members of the Board and the CEO of ASE Mr. Jalil Tarif, and representative of Jordan Securities Commission Mr. Majd Shafiq.

The meeting discussed the report of the Board of Directors on the activities of the ASE for 2011 and its future plan; the participants listened to the Auditor's Report including the balance sheet, final statements of account, and the financial position.
